

Liability & Waiver

- 1. Owner specifically represents that he or she is the owner of the dog, or has been authorized by the Owner of the dog to enter into this Contract as the Owner's agent.
- 2. Owner agrees to pay the boarding rate for services effective on the date the pet gets booked into Stay and Play dog boarding kennel. Rates are subject to change. Boarding extras are not included in the boarding rates.
- Owner understands that there is a full day boarding fee charged on day of arrival (regardless of check-in time), and there is a full day charge for the day of departure if check-out is 10 am or later.
- 4. Owner understands that extra charges will be added to bill for check in or out outside of the regular drop of or pick up hours.
- 5. Owner understands that a Trip Fee dependent on distance will be added to bill for each trip a Stay and Play representative makes to take pet to/from Owner's veterinarian, airport transfers and other trips, whether they be preplanned or unexpected.
- 6. Stay and Play dog boarding kennel shall transport pet to veterinary office in case of emergency, or in nonemergency cases where Stay and Play dog boarding has contacted the Owner or emergency contact.
- 7. Stay and Play dog boarding shall exercise due and reasonable care for each pet while boarding. Under this reasonable care, Owner releases Stay and Play dog boarding from, and waives all claims and liability against the Dog Boarding for or attributable to, injury or illness, or death of pet.
- 8. Owner agrees that Owner shall be solely responsible for any and all acts and behaviour of said pet while it is in the care of Stay and Play Dog Boarding. This includes damage to kennel structure and/or kennel property.
- 9. Owner represents that pet is healthy and has been exposed to any known communicable disease within the thirty-day period immediately prior to boarding. Owner aggress to disclose to Stay and Play dog boarding all known medical conditions and/or behaviour problems, which may affect pet's care prior to check-in.
- 10. Owner releases Stay and Play dog boarding kennel from, and waives all claims and liability against the Stay and Play dog boarding kennel for damage to, or loss of, personal equipment or belongings provided by Owner for pet while the pet is boarded.
- 11. We reserve the right to withhold 50 % of the total boarding amount as cancellation fee if notified less than two days ahead.
- 12. I understand that due to the nature of dog plays minor cuts and scratches are not uncommon even with careful supervision. In the event the pet has inflicted serious injury, however, I understand and hereby represent that I am solely responsible for any harm caused by the Pet while he/she is attending Stay and Play Dog Boarding.
- 13. I, the pet's owner, certify that I have read and understand the rules and regulations as set forth in this agreement. I agree to abide by the rules and regulations and accept all the terms, conditions and statements.
- 14. If the dog is allowed to be off leash and play with other dogs the owner is aware that despite always being supervised injuries can sometimes occur. On free runs dogs can encounter predators or porcupines or even get lost. The owner agrees to accept this risk and is responsible for any costs that may result out of these activities and exposures (i.e. vet transportation etc.).
